Festival Rules & Information – Read entire application before applying

Permitted. Handcrafted, artist-made products are welcome at the Festival, including prints, reproductions or cards of your art.

Prohibited Items. The following are prohibited: any work that artist did not make by hand or is not artist's own work or the work of a person(s) known to the artist approved by the Approval Committee. This includes but is not limited to buy-sell*, imported items, mass-produced items, and commercially manufactured items, all of which are prohibited.

If prohibited items are found, artist will be asked to leave the Festival and will forfeit all fees. Removal decisions are at the sole discretion of the Event Directors. Please do not apply if works include prohibited items.

Food items are not allowed (candy, sweets, jams, etc.), due to O.C. Health restrictions. Only food trucks are allowed to sell food to the public.

Photos. 2 or 3 Photos of artist works are required to be submitted for **all** applicants. Photos may also be used for publicity purposes. Additional information regarding artist process, materials, and/or products may be required by Artist Approval Committee for new or returning artists.

Booth Staffing. Booths must be open and staffed during the entire time of event. Artists that pack up early or leave a booth unattended will not be invited back.

Booth Fee. Booth fees are nonrefundable except in the event of cancellation due to pandemic or governmental mandate.

Insurance. Artists are responsible for maintaining general liability insurance for their booth space during the event for their personal protection against loss. The Yorba Linda Arts Alliance and the City of Yorba Linda Parks and Recreation Department and affiliates and agents will not be responsible for any exhibitor property damage. Please sign liability Waiver.

Booth Set Up. From 7:30 a.m. day of event. Booths must be set up by 10:45.

Parking and unloading. You will be directed to an unloading area, but vehicle must not remain in the unloading zone any longer than it takes to unload. Parking is available at the community center adjacent to the park.

Booth locations will be assigned based upon the order in which applications are received with due regard given to product mix, and an attempt to incorporate reasonable location requests when possible. Event Directors have sole discretion in assigning booth locations. Artists who complain about or do not cooperate with booth assignments/locations will not be invited back to Festival and may be asked to leave and forfeit all fees.

Weather. This event is rain or shine. Dangerous weather will result in temporary closure of Festival. ☒

Electricity. A limited amount of electrical outlets are available and may be requested.

There will be live music throughout the weekend. If you do not want to be located near the music, make note of that in the application.
